APPLICATION AND USE

The sanitary tapware "Mechanical mixers" are intended for application in drinking water installations with a static pressure of maximum 1000 kPa and a maximum water temperature of 90 °C. The recommended limits for correct operation are a dynamic pressure between 100 kPa and 500 kPa and a water temperature of maximum 65 °C.

MARKING

The Kiwa®-mark products are marked with the word mark "KIWA".
